



Russell City Council meeting

April 8, 2025

The Russell City Council held their regular meeting on Tuesday April 8th in the City Hall meeting room at 5:30 pm. Present at the meeting were council members Hilary Buchert, Glen Grant, Matt Kerkaert, Joel VanDamme and Dawn Garbe. Also present were Laurie Millner, City clerk, Jason Alberts, Public works director, Shelly Sanow, RBG lead bartender, Lyon County Sheriff Eric Wallen, Matt Gross, City attorney, Paul lurek, Bollig Engineering, leff VanBuren via teams, Mary Beth Oberloh via teams and members of the community.

The meeting was called to order with the pledge of allegiance by Mayor Buchert.

M/S/C Glen / Hilary to open the public hearing regarding Small Cities Development Grant Infrastructure Improvements project.

Paul Jurek made a presentation about the grant, what is remaining in the project, and what the grant would be used for if the City were to receive it.

M/S/C Glen/Joel to close the public hearing.

M/S/C Glen / Hilary to strike item 13 Shady Oaks request for Russell to sponsor trails

M/S/C Dawn/ Joel to approve the agenda.

M/S/C Glen/ Hilary to approve the minutes from the March 11th regular meeting.

M/S/C loel /Dawn to pay half the cost of the tent rented by the Bandwagon Committee for Bandwagon days. M/S/C Glen Joel to cap comp time hours for all full-time employees at 40 hours to be used by December 31 of the year earned.

M/S/C Glen/ Joel for the bar to be open on Sunday June 8th after the Bandwagon Days parade management to determine the hours.

M/S/C Hilary / Matt to approve resolution 2025-6 to declare the old POS excess equipment.

leff VanBurén spoke with the council regarding the temporary construction loan for phase I. All funds are now disbursed, he recommends we close on the permanent loan at this time.

M/S/C Joel/Matt to close on the permanent loan at this time.

The council instructed Laurie to contact MN Rural water regarding them helping the City do a rate study.

M/S/C Matt/Joel to sign the lease agreement for the skid loader for next year. M/S/C Matt/Joel to purchase MRX920 reader for \$11,500 using the credit of \$13,440 from the return of the tower reader, using the balance of the credit to purchase new meters.

M/S/C Matt/Joel to approve Resolution 2025-4 to declare the one-way plow excess equipment.

M/S/C Joel / Matt to approve Resolution 2025-5 to declare the Wagner paint sprayer excess equipment.

M/S/C Matt/Joel to work with Municipal impact to set up a website that will include a public notification system.

M/S/C Joel/Matt to approve Rob Buehlers request for long term medical leave of absence.

M/S/C Matt/loel to renew CD 3896 – Ambulance \$4,623.30 for 7 months.

M/S/C Matt/Joel to liquidate CD 4328 - \$46,909.64 to pay for 2025 insurance, early if needed to avoid penalties for late insurance. Hilary abstained.

M/S/C Matt/Joel to liquidate CD 4332 - \$5248.5 I proceeds to go to checking. Hilary abstained.

M/S/C Matt/Joel for Laurie to withdraw from 4M as needed to make monthly expenses leaving a minimum to keep the account open.

M/S/C Matt/loel for Laurie to attend Year 3 of the MN Clerks institute May 5 – 9 in Brooklyn Center.

M/S/C Hilary / Matt to approve March expenses as presented.

Next meeting is May 13th at 5:30 in the City Hall meeting room.

M/S/C Matt/Joel to adjourn the meeting.

Minnesota Memories May 2025...baskets, mothers & memorials

May Baskets, Mother's Day and Memorial Day memories come to mind in May. As I recall on the Ist of May, May Baskets (small baskets with candy) were left on the doors of family and friends (sometimes with romantic intent). For Mother's Day gifts we made little hand prints in plaster or silhouettes of our face in profile. Memorial Day found us marching behind the Legion firing Squad and School Band to the Cemetery to honor Russell's fallen veterans...I recall we little folks would receive a dime after the ceremony from the Legion which we immediately invested in a bottle or our favorite "pop". Over the years I suspect that all of the foregoing has appeared in previous newsletters... but they are good memories and on occasion bear repeating. The 8th of May this year marked the 80th Anniversary of the Allies 1945 WWII Victory in Europe (VE Day)...when Nazi Germany surrendered. I was a bit over 4 years old on that date but do remember it. I was playing in the farm yard when the news came and I asked if that meant my father was coming home. I was told, no because there was still ongoing war. VJ Day (Victory over Japan) would not come until August 1945. In May of 1945 Sergeant Alvin Burckhardt was in the vicinity of Heilbronn, in southwest Germany (German wine country – I would wager he sampled some) guarding German Prisoners of War and building Prisoner of War camps. Uncles Walter (Army Air Corps) and Keith Wixon (Marine Corps) were in the Pacific Theater of War as was my father (United States Navy). They would have been wondering what their fates might be in the continuing effort to defeat Japan. The atomic bombs mitigated their concern. All of these men were children of the Great Depression and had then found themselves thrown into the WWII cauldron. The lesson we can take from them is that the United States and its citizens have successfully navigated past economic and cultural chaos and uncertainty. I am confident we will manage the same during our current national and international challenges. On a lighter note, I hope you have all planted at least one tree this spring, and as June comes upon us do be looking for that first firefly/lightening bug of the season. © Marland J. Burckhardt

Stanley Alfred Stelter, age 70, of Lynd, Minnesota, passed away unexpectedly at home on April 23, 2025. While his departure came far too soon for those who loved him, his life was full of joy, generosity, and laughter — just as he would have wanted it.

A celebration of Stanley's life will be held at 11:00 a.m. on Monday, April 28, 2025, at Christ Evangelical Lutheran Church in Marshall, Minnesota. After a warm reception at the church, he will be laid to rest at Zion Evangelical Lutheran Cemetery in Island Lake Township. Visitation will be Sunday, April 27, from 5:00 – 8:00 p.m. at Hamilton Funeral Home in Marshall, with a prayer service at 7:30 p.m. followed by a time to share memories. Visitation will continue one hour prior to the service on Monday, at the church.

Stanley was born July 20, 1954, in Marshall, and grew up on the family farm in Island Lake Township. He was baptized and confirmed at Zion Evangelical Lutheran Church and gradu-

ated from Lynd High School in 1972. After earning a degree in computer science and electronics from Willmar Vocational College, Stanley served proudly in the United States Air Force.

On August 2, 1975, Stanley married the love of his life, Robin Groff, and they embarked on an adventurous start to their marriage, living in Idaho during his military service. When the call came to return home and care for the family farm, Stanley didn't hesitate. He farmed with pride for many years, cared for cattle with quiet dedication, and was still doing both until the day he died. Stanley also worked for ADM in Marshall and retired in 2021.

Stanley was a dedicated community member — active in his church, serving on the council and cemetery board, a proud member of the Russell American Legion, and a frequent blood donor with the Red Cross. But if you knew Stanley, you knew it was his heart that truly stood out.

He loved chatting with anyone and everyone. His motto was "A stranger is just a friend I haven't met yet." Whether at a grandkid's ballgame, a local auction, or just out and about, Stanley's kindness and humor lit up the room. He had a passion for collecting clocks, pinball machines, Jägermeister memorabilia, and of course, anything featuring Joe Cool.

More than anything, Stanley loved his family. He and Robin shared nearly 50 years of marriage and raised four wonderful children. His grandkids were the light of his life, and cheering them on from the sidelines was one of his greatest joys. Stanley also had a soft spot for his four-legged sidekick, Max, who was always by his side or posted up as the unofficial farm supervisor.

Stanley's absence leaves a big hole in many hearts, but the love, laughter, and lessons he shared will carry on for generations.

He is survived by his loving wife, Robin; 4 children and 12 grandchildren: Richard (Lisa) Stelter of Hartford, SD, with Mausten and Elle; Geoffrey (Tricia) Stelter of Marshall, with Lukas, Andrew, and Leah; Kristi (Jared) Steen of Orion, IL, with Wyatt, Bryce, Britton, and Jette; and Colin (Holly) Stelter of Lynd, with Brynn, Adilynn, and Maisie; his sister Sylvia (Julian "JD") Drelich of Norwich, NY; as well as nieces, nephews, and countless friends.

Stanley was preceded in death by his parents, Alfred and Ettie Stelter.

Stanley's life was one well lived and well loved. May his memory be as bright and welcoming as the man himself. Blessed be his memory.
