

Minnesota Memories July 2025.....things OBE

OBE (Overcome By Events) is an acronym I picked up somewhere/sometime during more than 33 years of military service. It has come to my attention that one of the "rules of thumb" from my Minnesota farm youth is now OBE. The old rule that 'corn needs to be knee high by the fourth' is OBE and probably has been for some years. For example, around the 4th my sources informed me that this year's crops look good in the Russell area, with corn currently taller than some of the town's senior citizens. What events contributed to the retirement of the knee high rule? I opine that improved varieties of corn, better and more fertilizer, improved weed control, and a bit of climate change are the events that have overcome the old rule – thus OBE. Some of the younger folks have probably never heard the knee high rule. Is there a new rule to replace the knee high rule? Fireflies continue their fluttering flirtatious flights and lights about our small acreage each evening. It is relaxing to sit and sip a libation while watching them flit around as dusk ends the day. This is especially the case when the day's news has irritated my sense of what is right and what is wrong. Anyway, by the time you read this the 4th of July 2025 will be a memory. I remember the Fourth as a welcome break from field work (some corn still needed cultivating) and a time to enjoy the carnival, dance and fireworks at Lyndwood. Sometimes there was also a family gathering and picnic, maybe on the shore of a lake for a little fishing. Uncle Gerald frequently brought some 'illegal' fireworks from South Dakota, putting our fingers in danger. Holidays lend themselves to memory making and reminiscing...we hope your Fourth was a memory maker. Farmers here are combining small grain (mostly wheat and barley) which demonstrates another case of OBE -"threshing" has been replaced by "combining" and what youngster can describe a "threshing ring" to you? The Russell City Council held their regular meeting on Tuesday June 10th in the City Hall meeting room at 5:30 pm. Present at the meeting were council members Hilary Buchert, Glen Grant, Matt Kerkaert and Joel VanDamme. Also present were Laurie Millner, City <u>clerk</u>, <u>Lyon</u> County Sheriff Deputy Matthew Boettger, Matt Gross, City attorney Paul Jurek, Bollig Engineering, and members of the community.

M/S/C Glen Grant/ Joel VanDamme to open the public hearing for the special use permit for Kerkaert's to have chickens. Matt Kerkaert abstained.

M/S/C Matt Kerkaert /Hilary Buchert to approve bidding for the bridge replacement project.

M/S/C Glen Grant / Matt Kerkaert to approve resolution 2025-9 A resolution of the <u>City</u> council of the City of Russell, MN supporting the request for state bonding for infrastructure improvements.

Glen Grant left the meeting at 6:10 pm.

M/S/C Matt Kerkaert /Joel VanDamme to pay \$823 which is half the tent cost from Bandwagon days out of the bar funds. Hilary abstained.

M/S/C Matt Kerkaert / Joel VanDamme to surplus the McCormick CX 85 tractor and research trade options for a new mower or sale options.

M/S/C Matt Kerkaert / Joel VanDamme to cash in CD 5908 at maturity and move to the 4M fund. Hilary abstained.

M/S/C Matt Kerkaert / Joel VanDamme to authorize Laurie to move money between the 4M fund and First Independent bank as needed up to \$20,000.

M/S/C Matt Kerkaert / Joel VanDamme to open a new checking account at First Independent Bank to be used for the Small Cities Grant. Hilary abstained.

M/S/C Joel VanDamme/ Hilary Buchert to approve the Special use permit for Kerkaert's to keep chickens. Matt Kerkaert abstained.

M/S/C Matt Kerkaert / Hilary Buchert to approve the Special use permit for VanDamme's to board 2 horses and keep chickens. Joel Van Damme abstained.

M/S/C Joel VanDamme / Matt Kerkaert to accept the monthly bills as presented.

M/S/C Matt Kerkaert / Joel VanDamme to adjourn the meeting.
